## Options for Handling Noisy Neighbours


**Talk to the neighbours.** Highlight what you have been experiencing and explore a solution with the neighbours.


# Noisy Neighbours Brought To Court

THE STRAITS TIMES reported in Feb 2016 up to 30 noisy neighbours have been hauled to court within the first three months of operation of Community Disputes Resolution Tribunal (CDRT).
