Long press for quick change in volume. Short press for one increment change. Short press to choose sound: bright white noise, deep white noise or surf.

Hold o and buttons at the same time to lock or unlock controls. Indicator light will blink 3 times.

hushh placement

We recommend placing hushh at least three feet (one meter) away from baby's ears. This lets the sound fill the room in order to provide the greatest sound-masking benefit.

Should you find yourself on-the-go with baby and wish to attach hushh to a stroller or car seat, we recommend setting the machine to partial volume. Do not place it directly against baby's ears. Your hushh has a locking mechanism to control the settings and volume. If the machine is within baby's reach, please lock the device to prevent accidental volume tampering.
